 - a. Modify the last sentence of the first paragraph to read: "Students may request to change their catalog year to the most current for their major by contacting the Office of the Registrar."
- 2. Action concerning Change of Grade:
 - a. Grade Changes policy paragraph in the catalog:
 - i. Add the following sentence as the first line of the policy: "Only faculty members may initiate the change of grade process."
 - ii. Remove the sentence: "Only faculty may complete the grade change form and submit it to the Registrar."
 - iii. In what is now the second sentence, change the word "Instructors" to "Faculty members"
 - b. Change of Grade Notification form:
 - i. Remove the line: "Submit to the Office of the Registrar"
 - ii. Change "Instructor's Name" to "Faculty Member's Name"
 - iii. For Signatures, change "Instructor" to "Faculty Member"
 - iv. Change the Grade Change Policy to the updated policy noted in 2.a. above.
- 3. Action concerning Incomplete form:
 - a. Add: "(Please print)" directly under "Name of Faculty Member"
 - b. Change "Course Number/Section" to "Course Title"
 - c. Add a line for "Course CRN"
 - d. Change "Term" to "Semester"
 - e. Policy section:
 - i. In the first sentence, add: "*" after the word "circumstances"
 - ii. In the first sentence, remove: ", and who has received a written time extension from the faculty member"
 - iii. Beneath the paragraph, add: "*Faculty may require documentation"
