Proof of having met or exceeded prerequisites* as follows (if applicable, copy of high school transcript and/or official college transcripts for credits earned outside NVCC must be provided by January 16, 2017):

- MATH:** Minimum of having completed, within the last 5 years*, high school algebra II with a grade of "C" or better **and** a placement or SAT/ACT score above intermediate algebra; **or** MAT*H137 or college level equivalent with a grade of "C" or better.
- BIOLOGY:** BIO105, BIO115, or BIO121 (or equivalent) completed within the last 5 years* with a grade of "C" or better.
- ENGLISH:** Minimum of having completed, with a "C" or better, developmental English course (ENG*H063 or equivalent); **or** AccuPlacer placement test results recommending ENG*H101; **or** SAT/ACT results for either Reading or Writing at or above the score for placement into ENG*H101 English Composition.
- GPA:** Minimum 2.5 GPA based only on the college courses with grades that meet the Respiratory Care Admission program curriculum requirements.

** "within the last five (5) years" is defined as having been completed in the Fall of 2012 or later.*

NOTE: Applicants who are enrolled in and plan to complete prerequisites during the winter may apply. Applicants who are enrolled in and successfully complete prerequisites during the spring semester may also apply, but will only be considered after all other eligible candidates have accepted or declined their position.

Admission to the Respiratory Care Program at NVCC is selective. You may qualify for this program by successfully completing the necessary prerequisites and other program admission requirements. The requirements listed are minimal admissions criteria and exceptions will only be considered on a case-by-case basis. Applicants who are not admitted to the Respiratory Care Program for 2017 and who wish to seek admission in subsequent years must reapply.

New or transfer students must submit an NVCC application and required documents to Admissions along with this program application. Applicants must provide the following as part of the College application process. Current or former NVCC students need only submit this program application:

- \$20 application fee (unless student has previously attended and paid the fee at another CT community college).
- Proof of completion of high school or GED unless applicant has earned a college degree, in which case the official college transcript with date of graduation can be substituted.
- Proof of immunity to Measles, Mumps, Rubella, and Varicella.
- Official transcripts of **all** previous college work, regardless of relevance to the Respiratory Care Program.

All qualified applicants will be invited to attend a mandatory program information session. In late February/early March, applicants will be contacted via their college assigned email address to schedule attendance at a session. The deadline to register for, and attendance at an information session is strictly enforced.

All communications regarding your Respiratory Care application status will be sent to your college assigned email address issued to you at the time of your acceptance to NVCC. Please be sure you are able to access this account and check it regularly. Instructions for accessing this account are included in your College acceptance email message sent to the email address provided on your NVCC College application.
