

<u>IMPORTANT</u>: This information is intended ONLY for <u>NON-DEGREE</u> students which includes those students not pursuing a degree program at NVCC, not enrolling full-time and/or not applying for financial aid. Student who are considered non-degree include:

- Students taking courses to meet requirements of their home college.
- Students who have chosen not to enroll in a degree program
- High school students taking an NVCC class prior to graduation
- Home schooled students who have not completed their high school requirements

Thank you for applying to Naugatuck Valley Community College for the Spring 2020 semester. The semester begins on Wednesday, January 22, 2020. If applicable, you will need to submit the documents listed below as soon as possible. Be sure to include your name and student/NetID #, which can be found in the subject line of your email message.

OPTIONAL DOCUMENTS (AS APPLICABLE):

- College transcripts: Unofficial transcripts may be submitted to be waived from the Accuplacer[®] Assessment Test (placement test) based on previous math and/or English courses and/or to meet course prerequisite requirements. Once your transcript is received and reviewed, we will send you an email letting you know if you need to take the placement test.
- SAT, ACT or GED test scores (optional): Submit scores to be waived from testing and determine math and/or English placement. Below the minimum required scores:

SAT (as of March 2016): 530 in Math and/or 26 in Writing Language, 25 in Reading, or 510 in Evidence Based Reading/Writing
SAT (prior to March 2016): 500 in Math and/or 450 in Critical Reading or Writing
ACT: 18 in Math and/or 21 in English, or 47 in English and Reading combined.
GED: 165 in Math Reasoning and/or 165 in Reasoning Language Arts

PLACEMENT TESTING:

If you do not meet the criteria above to be eligible for a waiver of the placement test based on SAT/ACT scores or prior College course work, please schedule your placement test for either the Waterbury or the Danbury Campus at http://www.nv.edu/accuplacer. **IMPORTANT**: You must bring a valid photo ID and your banner/student ID number to your testing appointment. We strongly recommend that you prepare in advance for taking the Accuplacer® test, as the test results may exempt you from having to take additional courses. ADVISING AND REGISTRATION:

- <u>Underage and homeschooled students</u>: Students must contact the Admissions office at (203) 575-8026 to schedule an
 appointment for advising and registration. High school partnership students will be notified of their assigned advising day.
- <u>All other non-degree students</u>. Advising is optional. The first day of registration is April 16th. To register for classes, you will need to login to the <u>myCommNet</u> student information systems. Your student ID/NetID# is located in the subject line of the email message.
