

## 2021-2022 Federal Direct Loan Request Form

Complete this form to request a Federal Direct Loan. Students have the option to borrow Federal Direct Student Loans to assist with costs associated with enrollment at our college. Although these federal loans carry favorable repayment terms and interest rates, it is advisable that you seek funding that does not need to be repaid, such as grants and scholarships, before you consider borrowing a federal loan.

## To be eligible for a Direct Loan, you must:

- Complete the Free Application for Federal Student Aid (FAFSA);
- > Enroll in an eligible degree or certificate program;
- > Enroll in a minimum of 6 credits per term; and
- Maintain Satisfactory Academic Progress.

## First-time Federal Direct Loan borrowers must also:

- Complete a Master Promissory Note (MPN) at studentaid.gov.
- Complete Entrance Loan Counseling at studentaid.gov.
