What is College Goal Sunday?

The College Goal Sunday program was created by Indiana Student Financial Aid Association with funding from Lilly Endowment, Inc. and supplemental support from the Lumina Foundation for Education. College Goal Sunday is a free, on-site program utilizes financial aid professionals and community-based service providers to assist students and their families with completing the Free Application for Federal Student Aid (FAFSA).

What should you bring?

- Your Social Security card or number
- Driver's License (if applicable)
- W-2 forms for 2015 and other records of money earned
- Your parent's Federal Income Tax Return for 2015 (If you are dependent student as defined by federal criteria)
- Your (or your spouse's, if you are married) 2015 Federal Income Tax Return
- Your untaxed income records for 2015- Social Security, Temporary Assistance to Needy Families, welfare, or veterans benefits records
- Your current bank statements
- Your current business and investment mortgage information, farm records, stock, bond, and other investment records
- Proof that you are a U.S. permanent resident or other eligible non-citizen
 Not all families will have all of the above information. Please attend College Goal Sunday and bring whatever documentation you have available.

What should you do to participate?

Follow these easy steps to apply for your FSA ID and to complete your FAFSA!

STEP 1:

COMPLETING THE FAFSA

- Go to WWW.FAFSA.ED.GOV to apply for your financial aid. (If you are a dependent student, you must enter information about your parents)
- Select the link "Start Here".
- Select the appropriate award year.
- Carefully read the instructions on the FAFSA and Click "Next". NOTE: BE SURE TO CLICK ON THE "BROWSE HELP" BUTTON ON THE TOP OF THE PAGE.
- Enter personal information. NOTE: you will be required to enter your social security number two times.
- Read "Information Page" carefully. Click "Next" to continue.
- Continue entering personal information.
- Periodically click the "Save" button to save the information you have added.
- Under the "School section", add our school code. NVCC's code is 006982. Then click "ADD".
- NEW: "Link to IRS" This will allow you to import your tax information that you filed with the IRS. Follow instructions carefully.
- Sign using your FSA ID. Remember: If you are a dependent student, you must also enter your parent FSA ID.
- Select "I agree" and then submit your FAFSA.
 - Print or write your confirmation number down for future use.

Please allow 8 to 10 working days for your FAFSA to be sent to NVCC from the Federal Government. If you have problems completing your FAFSA call 1-800-433-3243.

HOW TO APPLY FOR AN ESA ID

- Go to <u>fsaid.ed.gov</u> and click login. (If you are a dependent student your parent must also apply for an FSA ID.)
- Select "enter FSA ID" and then click on the link to create an FSA ID
- Create a username & password and enter your email address.
- Enter your name, date of birth, Social Security number, contact information, and challenge questions and answers.
- 5) If you have a Federal Student Aid PIN, you will be able to enter it and link it to your FSA ID. You can still create an FSA ID if you have forgotten or do not have a PIN.
- Review your information, and read and accept the terms and conditions.
- 7) Confirm your email address using the secure code, which will be sent to the email address you entered when you created your FSA ID. Once you verify your email address, you can use it instead of your username to log in to the websites.

You can use your FSA ID right away. Once the Social Security Administration verifies your information in 1-3 days, or if you have linked your PIN to your FSA ID, you will be able to use your FSA ID to access the website. For help, visit **StudentAid.gov/fsaid**.
