From the outcomes and objectives listed, it does not look like competency outcomes 1.4, 2.3, 3.3, 4.1, 4.2, 5.3, or 5.4 are being met.

The idea of a waiver was discussed but the nursing program is already using the maximum 2 waivers.

It was noted that the program currently has COM100 as a requirement which meets the oral communication competency. A. Lenoce said the department was hoping to have NUR101 approved under oral communication in order to free up an elective.
