DAN H101 History and Appreciation of World Dance

Aesthetic Dimension – Course was approved and is in the General Education framework. The committee was unsure if the outcomes submitted are new or are the outcomes previously approved.

DAN H102 Ballet 1: Renaissance to Romantic Written Communication Course competency 1.1 needs to be revised and read as follows Identify and evaluate the audiences and performance value for a variety of ballets, and adapt their writing about dance for the requirements of academic audiences and purposes.
