PSY 240: Needs a course outcome to match Competency Outcome #3. Also, needs to take out unnecessary course outcomes from Competency Outcome #4

PSY 217: Does not have measurable outcomes

SOC 201: Needs to remove unnecessary course outcomes for Competency Outcomes #3 and #5. Also, missing a course outcome for Competency Outcome #4
